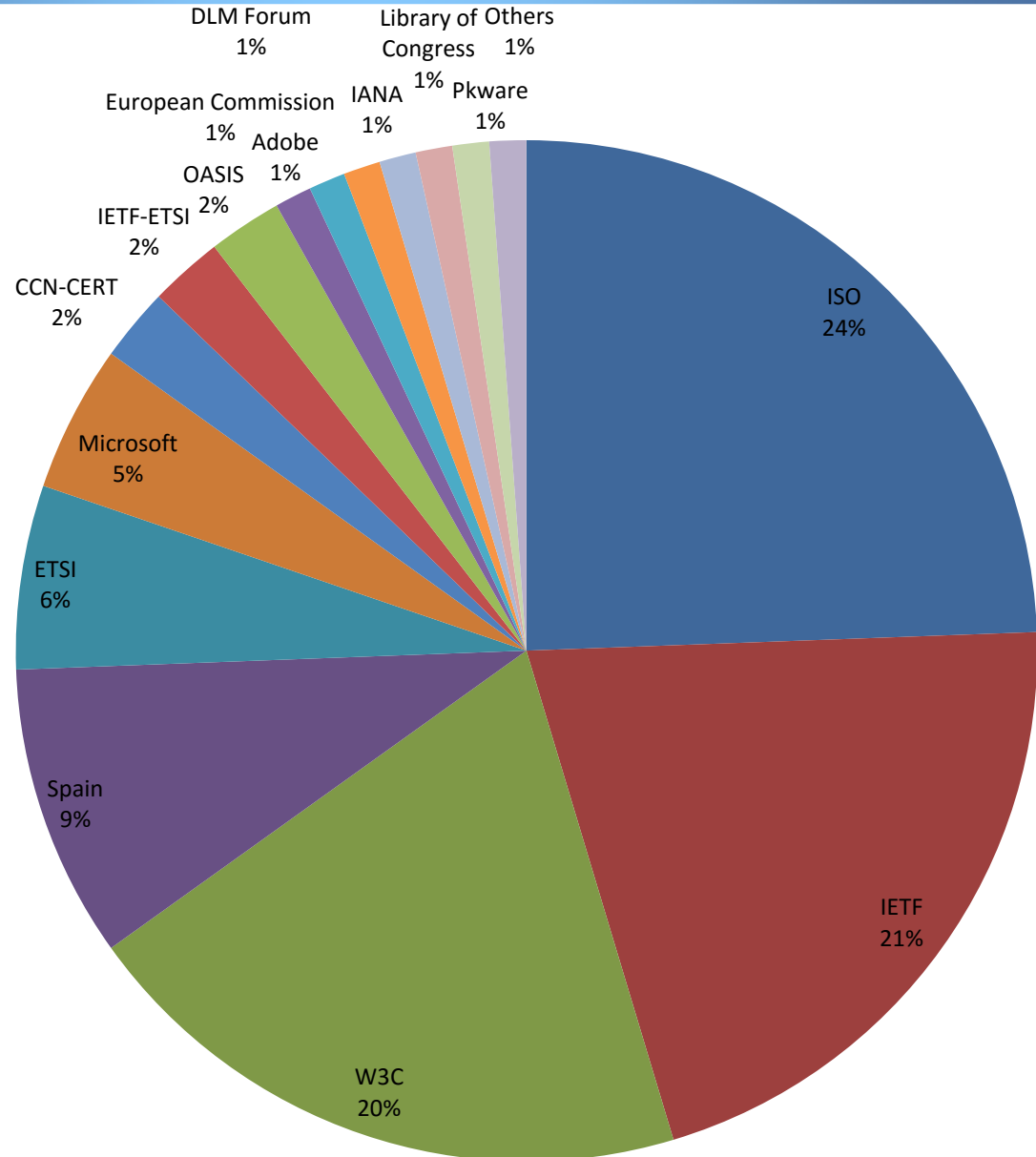

Technical standards on Information Society services.

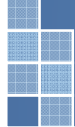
Standard: a technical specification approved by a **recognised** standardisation body. i.e. ISO, CEN/CENELEC, ETSI, National Body **(BUT NOT W3C, OASIS....)**

Only Standards are eligible for referencing in **public procurement**

Applicable both at European and National level

Regulation (EU) 1025/2012

Identification of ICT technical specifications for **public procurement**

- Proposals from Member States or Commission
- **Multi-Stakeholder Platform (MSP) to advise**
- Criteria for identification (Annex II)

MSP Mission: Advisory Expert Group on all matters related to European ICT Standardisation:

- Advise the Commission on its ICT Standardisation workprogramme
- Identify potential future ICT Standardisation needs
- Advise the Commission on possible standardisation mandates
- Advise the Commission on technical specifications in the field of ICT which regard to its **referencing in public procurement** and policies
- Advise the Commission on cooperation between standards developing organisations

Examples: W3C XML, IPv6, LDAPv3, DNSSEC.....

COMMISSION IMPLEMENTING DECISION (EU) 2016/120

XBRL 2.1 is a technical specification for digital business reporting, managed by a global not for profit consortium, XBRL International. The consortium is made up of approximately 600 public and private sector organisational members from around the world. **The goal of this consortium is to improve reporting in the public interest.**

XBRL 2.1 can be applied to a very wide range of business and financial data. It streamlines the preparation of business and financial reports for **internal and external decision making**. By using XBRL 2.1, companies and other producers of financial data and business reports can **automate the processes of data** collection.

THE EUROPEAN COMMISSION HAS ADOPTED THIS DECISION:

Article 1 **The eXtensible Business Reporting Language version 2.1 is eligible for referencing in public procurement.**

Article 2 This Decision shall enter into force ... the Official Journal of the European Union.
